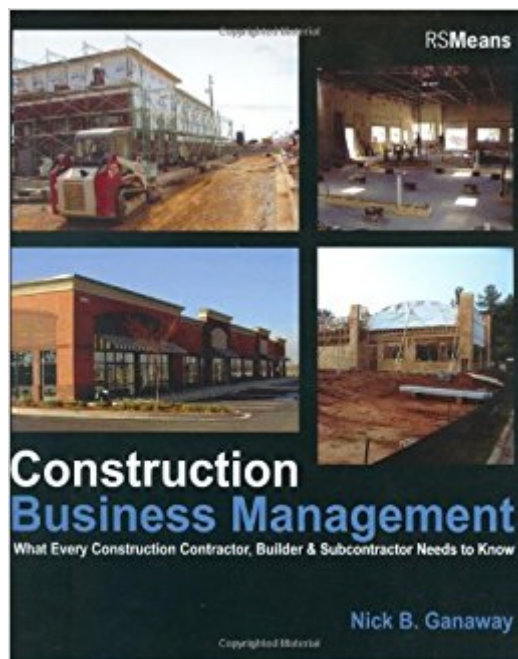

In this book, the author, Nick B. Ganaway,, shares what he has learned; sometimes the hard way; to help contractors, builders, and subcontractors minimize the pain and risk of operating a construction business; especially in their first few (riskier) years.
