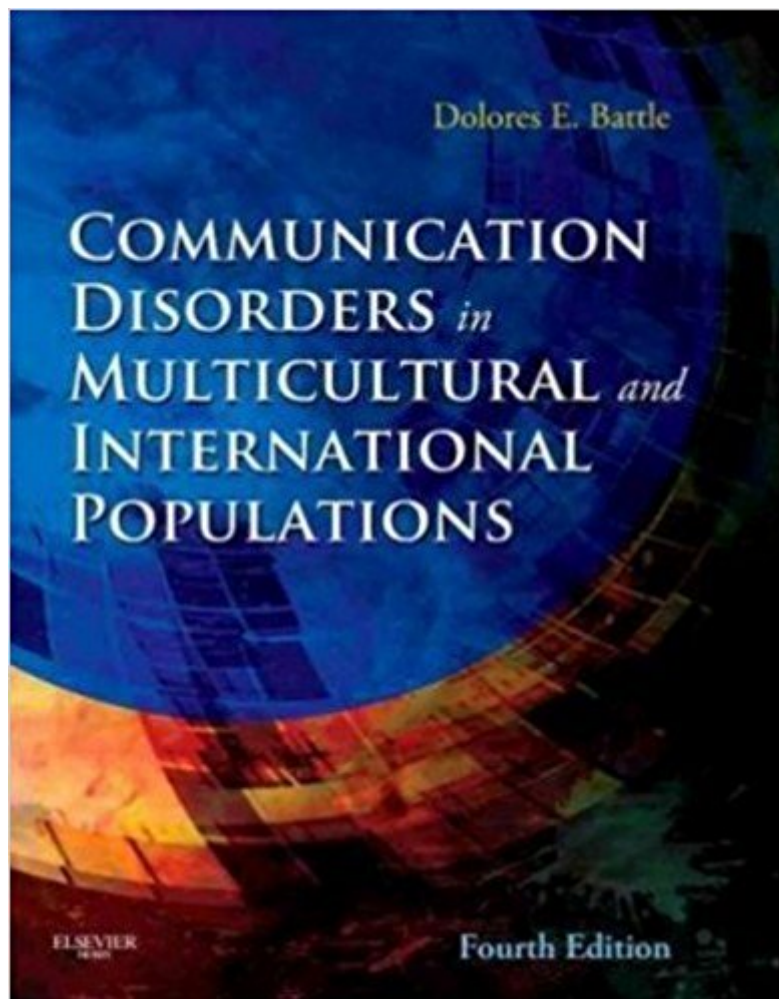

Given that the profession is more global and international, this textbook is unique and a welcome addition to the available literature. Of particular importance is the chapter on voice disorders and also the chapters on language development and indigenous groups because of their global focus. The chapter on global issues in hearing impairment is quite comprehensive and authoritative. References and resources are up to date. It is nicely written and the cover design is striking.
